After Burgess I went to the University of New Mexico in Albuquerque on a Navy ROTC scholarship. I admittedly partied a great deal the first couple years (Kappa Sigma animal house frat was great fun). Dropped the scholarship and continued school, supporting this activity by working. First job was with Southwest Air Rangers and while there I gained a private pilot's license.
